John Snapp awarded Iowa's top historic preservation honors

John Snapp, who spoke at the Society last November on railroads in Iowa and particularly about Cherokee County railroading, recently received the top award granted by The State Historical Society of Iowa and the nonprofit group Preservation Iowa. He was named the Martha Hayes Preservationist of the Year.

John graduated from Immaculate Conception High School in Cherokee in 1967. He spent some time attending Iowa State University and the University



of Iowa. He worked 40 years in railroading for the Illinois Central – Chicago, Central and Pacific and Canadian National Railroads. His jobs during this time included station man, clerk, relief agent, brakeman, switchman, conductor, Area Manager, Trainmaster, Manager of Grain Equipment, and Director of Freight Equipment. John retired to Cherokee. (his previous 23 years were spent at Waterloo)

His retirement has found him very busy volunteering in community affairs including Depot Renovation, Inc. and Cherokee Area Archives. He was

appointed to the Cherokee Historic Preservation Commission, serves as an officer and also assists with grant writing and photography.

John spoke about "The Importance of Railroads in Iowa" at the Historical Society Building on Sunday, November 4 at 2:00 p.m. There was an excellent line-up of photographs which he projected onto a screen. His presentation was well attended and very well received.

Elaine Rassel of the Marcus News gave a report of the program in the Nov. 15, 2018 issue. Some of the highlights of her article include a timeline beginning in 1851, the year the Illinois Central charter was issued. In 1853 the Dubuque and Pacific Railroads were chartered by the Iowa Legislature to build to the Pacific Ocean. 1855: Illinois Central tracks completed to Dunlieth (East Dubuque). 1856: work begins in Iowa. Reaches Dyersville in 1857 but construction work is halted by the panic of 1857. 1859: The Dubuque and Pacific reorganize and reschedule construction. 1860: Dubuque and Pacific reaches Jesup (IA) but is reorganized as the Dubuque and Sioux City Railroad due to financial problems. 1861: Dubuque and Sioux City rails reach Waterloo and then Cedar Falls. Work halts because of the Civil war. 1867: Illinois Central leases the Dubuque and Sioux City railroad. John Blair is brought in to oversee final construction. 1868: Railroad bridge over the Mississippi is begun with the first train crossing the bridge in 1869. Also in 1869 track laying crews which started at Sioux City reach Marcus in the fall. Tracks reach Hazard (now known as Meriden) by December. Work halts for winter. Work begins on the first Marcus wood frame depot. 1870: Marcus depot completed. On July 8, 1870 track laying crews meet midway between Alta and Storm Lake and the line is completed. 1887: Cherokee and Dakota Railroad organized to build 96 mile line from Cherokee to Sioux Falls and 61 mile line from Cherokee to Onawa. 1917: Original wood frame depot at Marcus replaced with a new brick depot. 1971: Passenger service on the Iowa Division of the Illinois Central discontinued with the last run of No. 12 on May 1.

Where did the money come from? Because railroads could not be built out of the public treasury by appropriations the government found another plan. Public lands to the amount of every other section on each side of a right of way for a specific number of miles would be granted to any corporation that would build and maintain said rail line.

The railroad made Marcus accessible to farmers in search of land, (purchased from the railroad or other sources), storekeepers to support the farmers and other residents, and provided a means to ship grain and livestock. This names just a few benefits.

Second Grade Visitors

On May 31st we had 20 second grade children along with their teachers, Mrs. Kris Irwin and Melissa Utesch, and their helper, Cheyenne Olson, come to visit the Historical Building. They were very interested in all of the displays and asked a lot of good questions. Dr. Joynt's car is always a highlight, and it was a treat to have them visit.
